

3. As per Maharashtra Public University Act 2016, if less than 65% marks are obtained in form A, B, or C in the next three consecutive years from the academic year 2019-20, It is to be seriously noted that the proposal for de-affiliation procedure under Article 120 will be submitted to the University Authority Board.

Since the approval of renewal / natural extension of affiliation is subject to the fulfilment of the conditions laid down by the local inquiry committee and the scrutiny committee, the college should fulfil all the said conditions and submit the condition fulfilment report to the university within two months from the date of this letter. Please note that approval for renewal of the said affiliation will be maintained only after fulfilment of those conditions and approval of the same by the faculty Council.

Also due care should be taken to submit the proposal for further affiliation approval to the university along with the prescribed fee within the stipulated time.
