The Aims of both the Trusts being same and equal both the trusts, by an order dated 28/05/1993

passed by Ld. Deputy Charity Commissioners, Kolhapur have being amalgamated and the trust is continued by the name Balasaheb Mane Education Trust, Rukadi. Therefore the ownership above said property has been transferred in the name of Balasaheb Mane Education Trust, Rukadi and as such a mutation entry no. 395 dated 16/10/2006 has been effected to the property card of the above said property from these mutation entry it is clear that the above said property is owned by Balasaheb Mane Education Trust, Rukadi.
