RESTORATION ORDER

WHEREAS, recognition was granted to the institution, namely to **BALASAHEB MANE EDUCATION TRUST, AT. POST RUKADI, TAL. - HATKANANGLE, KOLHAPUR-416118, MAHARASHTRA** under section 14 (3)A of NCTE Act, 1993 for conducting B.Ed. course (100 Intake) vide order No. WRC/5-6/86-87/2006/8067 dated 31.08.2006.

2. **AND WHEREAS**, Revised Recognition order was issued to **BALASAHEB MANE EDUCATION TRUST, AT. POST RUKADI, TAL. - HATKANANGLE, KOLHAPUR-416118, MAHARASHTRA**, vide order No. F.No. WRC/APW00787/123121/2015/1148761-768 dated 31.05.2015 for B.Ed. of Two Years Duration with an annual intake of 50 students (one basic unit of 50 students) from the academic session 2015-2016.

3. **AND WHEREAS**, Compliance was not submitted as per regulations 2014.

4. **AND WHEREAS**, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."

5. **AND WHEREAS**, a Show Cause notice was issued to the institution on 27.02.2017 for not submitting the documents in compliance of Regulation 2014 mentioned in the revised order:

6. **AND WHEREAS**, the reply of show cause notice was not submitted by the institution.

7. **AND WHEREAS**, the matter was placed in 316th Meeting held on August 27-28, & 04 September 2020 of WRC and the Committee decided that. "The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made: -

"...The WRC considered the entire issue in detail and noted that as per NCTE Regulations dated 13.11.2002. Initially institutions were permitted to start the course in a rented-premises with a condition to shift to their own premises within a period of three years from the date of such recognition.

From the Agenda note placed before WRC, it is observed that many Institutions have not yet shifted to their own premises neither they have applied to WRC for shifting of premises of their institutions.

The WRC considered the entire issue in detail and decided that Show Cause Notice u/s 17 of the NCTE Act be issued to reply within 30 days to all such institutions which have been permitted or given recognition / permission to run the programme in rented premises and have not yet applied for shifting of their institution.

Further, the WRC also decided that the applications of the institutions who have applied for shifting of premises be examined by office at the earliest and placed before WRC for consideration and decision."

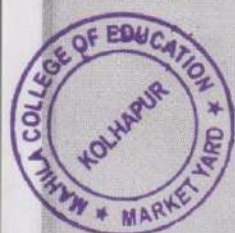
8. **AND WHEREAS**, the Show Cause Notice was issued to the institution on 29.09.2020 as per decision of WRC, and its reply not received from the institution.

9. **AND WHEREAS**, the matter was placed in 322nd Meeting held on November 23-24, 2020 of WRC and the Committee decided that:-

"...The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:

1. Recognition was granted to the institution on 31.08.2006 on rented premises with a condition that to shift the institution in its own premises within a period of three years from the date of issue of recognition order.
2. The institution has not shifted the institution in its own premises till date.
3. Accordingly, Show Cause Notice was issued to the institution on 29.09.2020.
4. The institution has not submitted the reply of the Show Cause Notice till

In view of above, the Committee decided that the recognition of B.Ed. programme of the institution be WITHDRAWN under section 17 (3) of the NCTE Act from the next academic session 2021-22."

10. **AND WHEREAS**, the Withdrawal order was issued to the institution on 20.12.2020.
11. **AND WHEREAS**, the institution filed an Appeal to the Council on 01.02.2021 and the Council vide its order dt. 02.06.2021 remanded back the case to the WRC, NCTE for necessary action.
12. **AND WHEREAS**, the matter was placed in 339th Meeting held on July 28-30, 2021 of WRC and the Committee decided that:-

"... This is a RPRO case and same was remanded back by the Appellate Authority.

The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation were made:

The institution has not submitted the following documents :-

1. Certified copy of land documents
2. Non Encumbrance Certificate issued by the Competent Authority
3. Fire Safety Certificate Issued by the Competent Authority
4. Building Safety Certificate issued by the Competent Authority
5. Building Disabled Friendly Certificate issued by the Competent Authority
6. Land Possession / Mutation Certificate issued by the Competent Authority
7. Staff list duly approved by the affiliating body for the staff presently working in the institution.
8. The resolution of the society is In Marathi language. The institution is required to submit the translated version of the same duly notarized.

In view of the above, the Committee decided that last opportunity be given to the institution to reply within 30 days u/s 17 of the NCTE Act for B.Ed. programme."

13. **AND WHEREAS**, the Final Show Cause Notice was issued to the institution on 14.08.2021. and its reply from the institution on 03.09.2021.
14. **AND WHEREAS**, the matter was placed in 347th Meeting held on 03-05 December, 2021 of WRC and the Committee decided that.

"...This is a RPRO case and same was remanded back by the Appellate Authority.

The WRC examined the documents submitted by the institution and observed that the institution has complied with the requirements laid down under NCTE Regulations and decided that the recognition granted to the University for B.Ed course with an annual intake of 50 students (one basic unit of 50 students) be restored."

15. NOW THEREFORE, recognition dated 31.08.2006 and revised recognition order dt. 31.05.2015 issued to the institution viz **BALASAHEB MANE EDUCATION TRUST, AT. POST RUKADI, TAL. - HATKANANGLE, KOLHAPUR-416118, MAHARASHTRA** for B.Ed. course with an annual intake of 50 students (one basic unit of 50 students) is hereby restored.
